




- 4. All sheep will be sold under the Conditions of Sale of the Livestock Auctioneers Association.
- 5. Transfer Fee- A fee of £5 will be charged to the purchaser is they wish to transfer their purchase to their flock.
- **6.** All sheep to be fully registered with the Badger Face Texel Society . All sheep must have official ear tattoos or tags and also be tagged in accordance with the relevant DEFRA regulations. The Vendor shall be responsible for the correctness of identity.
- 7. Pre Sale Inspection All sheep forward for sale will be subject to a Society inspection. Any animal which does not reach the inspection standard will not be eligible for sale. The inspection decision will be final and any animal failing, must be removed immediately from the sale and forfeit the entry fee. No appeal is permitted.
- **8.** Substitutes Details of Substitutes must be submitted to the Auctioneer/ Society Secretary 24 hours prior to sale.
