## **Conditions of Entry and General Information**

- 1. Entry is open to MV Accredited Sheep only.
- 2. All sheep must be registered with the Badger Face Texel Sheep Society, prior to the closing date of entries, with the exception of the Recipient dams. NO UNREGISTERED ENTRIES WILL BE ACCEPTED
- 3. Classes available for Pedigree Ewes & Lambs, embryo Lambs Suckling Recipient Dam, Ewe Hoggs
- 4. All sheep must be double tagged. The vendor shall be responsible for the correctness of identity. Any tags which are tampered with, hand written/bear marks, are faulty or illegible will be rejected from the sale.
- 5. A Society Levy of 1% will be deducted from the vendors account and paid to the Badger Face Texel Sheep Society.
- 6. A Transfer fee of £5 will be charged to the purchaser if they wish to transfer their purchase into their flock.
- 7. Entry Fee a fee of £12 per unit will be charged on all entries (£10 + VAT). Cheques to be made payable to Harrison & Hetherington Ltd and must accompany the completed entry form unless paying by BACS.

- 8. Scrapie Genotyping is voluntary. Genotype information to be displayed in the sale catalogue must be supported by valid genotype certificates forwarded along with the sale entry forms and pedigree certificates.
- ALL substitutes to be notified to Harrison & Hetherington. All substitutes must be notified by 12noon on Wednesday 24<sup>th</sup> May and must be marked with a red dot on the loin.
   No substitutes will be allowed at the point for Arrival of Stock.
- 10. All Pedigree Females are sold with a Vendors Warranty, full details of the warranty's are available from the Badger Face Texel Sheep Society.

**PRE-SALE INSPECTION:** All sheep forward for the sale will be subject to a Society inspection. Any animal which does not reach the Inspection standard will not be eligible for show or sale. The inspection decision will be final and any animal failed must be removed immediately from the sale and forfeit the entry fee. No appeal is permitted.

**Acceptance of stock:** Due to Defra regulations, the arrival of stock can only be accepted onto the market premises within the time period stated in the sale catalogue. Any alteration will be notified to all vendors, however, we request that all arrival times must be strictly adhered to.
