Classes available for:

CLASS 1 BULL (registered)

CLASS 2 COW (registered)

CLASS 3 HEIFER (registered – maiden, in-calf or with first calf at foot)

Classes 1 - 3 will be judged in the ring and presented with rosettes and prizes to 3rd place.

Class 3 will be split if number of entries suffice.

Champion and Reserve Champion will receive a Special Rosette.

CLASS 4 BEST PEN OF UNHALTERED REGISTERED DEXTERS

CLASS 5 COMMERCIAL – FOR SALE ONLY
(Steers, Unregistered and Cross-bred)

It is the Vendors responsibility to ensure that all UK tag numbers are correct

Inspection: All cattle forward for the sale will be inspected prior to the Sale. All animals must conform to the Breed Standard. If any lots do not conform to the Breed Standard a red dot will be marked on the lot ticket number and the reason will be announced by the auctioneer as the animal enters the sale ring. Any animals showing symptoms of infectious or contagious diseases will be removed from the lines and will not be allowed to be sold.

Any calves under 12 months of age which are sold separate from the dams must be weaned at least 3–4 weeks prior to sale.

Cattle Passports: All cattle must be accompanied by a Passport which must be handed over to the auctioneers or stewards on arrival. All cattle including calves must be accompanied with a relevant cattle movement document (available from the market) duly completed and signed. Cattle arriving without a Passport or signed cattle movement document will not be permitted on to the market premises.

Conditions of Sale: All registered cattle will be offered for sale subject to the terms and conditions of sale recommended by the National Beef Association. A copy of these terms and conditions will be displayed at the sale premises and will be available in booklet form for vendors and purchasers who may require them at the sale.

Entry Fee: There will be an entry fee of £15 + VAT per animal (£18.00). All entry fees must accompany all entry forms, failure to do so may lead to non acceptance of entry.

Transfer Fee: Official Pedigree Transfer will be effected by the Auctioneers and the Dexter Cattle Society as soon as possible after the sale. Full Pedigrees will be transferred at a fee of £11 (inc VAT) and Birth Notified will be transferred at a fee of £4 (inc VAT) payable by the vendor.

Method of Sale: All cattle will be sold in strictly catalogue order, unless any alteration is announced by the Auctioneers.

TB Testing: Please refer to the following guidance regarding TB testing - [Guidance: bovine TB pre-movement and post-movement testing - GOV.UK \(www.gov.uk\)](https://www.gov.uk/guidance/bovine-tb-pre-movement-and-post-movement-testing).

BVD: All cattle consigned from a Scottish holding must be BVD tested.

Please state on the entry form if the animal(s) have been BVD tested and/or vaccinated.
