New customers and or agents wishing to purchase on behalf of another party must contact the company's main office at Carlisle at least 48 hours prior to sale,

to provide full details and references for authorization.

Please note that all lots/items must be settled on the day of purchase and prior to clearance of any stock.

For the avoidance of doubt H&H reserve the right to contra or keep sale proceeds to offset against an outstanding account.

All sheep consigned to this sale must be accompanied by a completed AML1 movement document and all vendors must ensure that holding and flock numbers are supplied Please ensure that all Sheep are ear tagged to comply with regulations.

If any Lot or any vendor is not present when the sale order time is reached, such lot will be passed over and offered for sale at the end of the sale.
