Conditions of Entry and General Information

1. The Sale will be held subject to the General & Special Conditions of Sale of the Institute of Auctioneers and Appraisers in Scotland.
2. The Sale of Rams is confined to Hill and Park rams of One Shear and upwards. Ram lambs are not acceptable for either sale.
All Rams must be registered with the Society prior to entry.
3. **Ballot:** the sale ballot for both the Park and Hill Ram Sales will be drawn on Monday 17th August.
The rolling ballot will continue, 9 vendors, who entered & attended the sale with stock, will move forward from the bottom of the sale each year & will then also be re-balloted within the 9.
New vendors will be balloted into the sale throughout.
Any consignor who enter rams but do not arrive at the sale (without prior notification and good reason) will be regarded as a new consignor the following year.
Any consignors whom do not enter every year will be treated as a new consignor each time they do.
4. **RAMS:** Sheep may be inspected by a panel of NCCSS inspectors and if any are not deemed pure, will be removed from the sale, inspection of rams will commence at 7.00am on both sale days.
Vendors are not permitted to attend the mouth inspection.

Mouth Inspection appeals will no longer be in place – Vets decision will be final.

Any vendors found to be tampering with mouth and/or teeth for the mouth inspection will have their rams removed from the sale.
5. **Entry Fee:** A Ram entry fee of £6.25 (+VAT) £7.50 per head. Cheques to be made payable to Harrison & Hetherington Ltd and must accompany the completed entry form. Entry fees are non-refundable.
6. **Park Rams:** The show for the Park Rams will commence at 9.00am on the morning of the sale. All rams must be penned by 9.30am. The groups will also be required to be out for judging at the same time.

7. **Hill Rams:** There is no show for the Hill Rams. All rams must be penned by 10.30am.
The Society have requested that all consignors of Hill Rams must indicate if their rams have tested free from Achondroplasia.
8. **Showing of Rams:** A limit on the number of rams permitted for show is – one ram per consignor up to five rams entered and two rams thereafter, a maximum of two rams per consignor.
9. **Upset Price:** The Society Ruling for the upset price is £300 per ram.
10. **FEMALES:**
Park Females – classes available for ewes, gimmers and ewe lambs. Entries close on Tuesday 11th August. Sale will commence at 10.30am.
Hill Females – classes available for ewes, gimmers and ewe lambs. Entries close on Tuesday 25th August.
Unregistered Females will be sold after the registered females of each section.
No more than 2 singles females to be sold per section/vendor, if only 3 entered – 1 x single & a pair.
11. **Society Levy** – a ram levy of 3% and a female levy of 10p per sheep will be deducted from the vendors account and paid to the North Country Cheviot Sheep Society.

Acceptance of stock: The arrival of stock can only be accepted onto the market premises within the time period stated in the sale catalogue. Any alteration will be notified to all vendors, however we request that all arrival times must be strictly adhered to when published in the catalogue.

Export to Northern Ireland: As of 1 January 2021, the rules for exporting sheep from the United Kingdom to Northern Ireland and the European Union have changed for moving breeding stock to Northern Ireland – **NO Direct Export or Vendor Returns will be available.**

It will be the responsibility of the purchaser and/or the vendor to make any necessary arrangements for sheep going to Northern Ireland.

Disclaimer: The responsibility for export of sheep rests with either the purchaser or the vendor and not Harrison & Hetherington Ltd nor the North Country Cheviot Sheep Society.
