Claims must be intimated within 49 days from the date of sale and be accompanied by a Veterinary Surgeon's certificate stating ear number of animal and the defaulting party will be responsible for all expenses incurred. Cows and Heifers with calves at foot are to be free of calf at time of sale unless otherwise declared.
